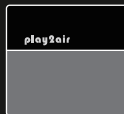

## Setup Play2Air

1. Plug the Type-C side of the cable into bottom of the Play2Air Device.
2. Plug the other side of the cable into the USB(or Type-C) port of wired CarPlay head unit/infotainment system.



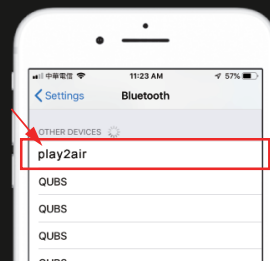
3. Turn on the head unit/infotainment power if it is switched off (or turn the Engine on).

## Pairing For The 1st Time

Please plug the product into USB/Type-C port of vehicle system and make sure that your iPhone's mobile network is turned on:

1. Go to iPhone's Bluetooth setup menu and look up for "play2air" to connect after the blue LED light flashes. (Figure 1)
2. Press "Use CarPlay" to start when the CarPlay inquiry window pops up.
3. Your iPhone's WiFi will automatic connect with your car system within 10 seconds. (Figure2)
4. You can now control CarPlay User Interface as you normally would through a wired connection. Start enjoying your CarPlay system !

## Connecting with Another iPhone

If you want to pair and connect another iPhone with Play2Air, please switch off Bluetooth of the first iPhone to disconnect with Play2Air and follow the pairing instruction again for the second iPhone.

## Auto Reconnect

Your iPhone should reconnect with your head unit/infotainment as soon as you restart engine and turn the head unit/infotainment's power on. Please make sure that you keep the iPhone's WiFi on all the time in order to enjoy the auto-reconnection feature.
